## **Registration Information**

- The buy in fee for congregations is **\$450** and is due on **April 1**, **2024**.*If an invoice is needed, please reach out to Sarah at scracraft@gmail.com.*
- Registration Fee for Heroes, Pathfinders, Saints, GGP, MBC, LT and Staff is **\$450 per person**.
- Counselor Registration Fee is \$250 per person. (See separate instructions for Counselor info)
- Please submit registration information by April 1, 2024.
- Please be sure you are using 2024 forms old forms will not be accepted. Registration forms are available at the camp web site: <u>harrisburgconfirmationcamp.org</u>
- Use the same form for all registrants except staff (different form for staff). Please be sure to check participation level on each camper's form.
- All youth should register with their grade level even if they have not completed the prior year of camp.
- All participants **must submit a waiver of risk**. This is not optional, no waiver, no attendance.
- Counselors and staff must submit the following information for Camp to comply with the Pennsylvania Child Protective Services Law (CPSL) revised in July of 2015. New staff and counselors will need to secure the following clearances and submit by April 1, 2024:
  - 1. Pennsylvania State Police Criminal Record Check https://www.dhs.pa.gov/KeepKidsSafe/Clearances/Pages/Criminal-Background-Check.aspx
  - 2. Pennsylvania Child Abuse History https://www.dhs.pa.gov/KeepKidsSafe/Clearances/Pages/PA-Child-Abuse-History-Clearance.aspx
  - 3. Federal Bureau of Investigation Criminal Background Check (Fingerprint) <u>OR</u> Signed Affidavit if a resident of PA for 10 years (must be signed new each year)
- Registration information should include:
  - **Registration Forms** for all staff and campers (including medical information). Young Adult Leader/Counselor forms should have been submitted directly to Counselor Selection.
  - **PA Child Protective Clearances** as listed above.
  - **A list of all participants** (including staff and counselors) by Curriculum/Track that includes Name, Address, T-shirt size, Phone and Email (Example provided on back of page)
  - One Consolidated Check is preferred from each congregation and should be included with the registration information <u>made payable to: Harrisburg Area Confirmation Camp</u>
- Registrations will be processed in the order received. All forms must be submitted. Please do not submit a list only. Registrations will not be accepted without payment.
- Please check that all the information on your forms is complete before submitting.
